### STATE OF IDAHO SUPPLEMENTAL CONTRACT FORM

THIS AGREEMENT, made this date, June 25, 2012, by and between Canyon-Owyhee School Service Agency School District #555, Wilder, Idaho ("the District") and MICHAEL A BRUSHAFER ("the Employee").
